

# 飯能市小規模事業者応援金

新型コロナウイルス感染症の影響により売上が減少している市内小規模事業者の事業の継続を支援するため、**一律10万円**の応援金を給付します。

## 対象事業者

飯能市内に主たる事業所を有する「小規模企業者」

※小規模企業者とは、会社又は個人事業主で、常時使用する従業員の数が以下に該当する事業者のことをいいます。

- 小売業、卸売業、サービス業 5人以下
- その他の業種 20人以下

### ◆対象外となる事業者

- ・飯能市暴力団排除条例に規定する暴力団・暴力団員
- ・風俗営業等の規制及び業務の適正化等に関する法律に規定する「性風俗関連特殊営業」、当該営業に係る「接客業務受託営業」を行う事業者
- ・政治団体、宗教上の組織又は団体、その他趣旨に照らして適当ではないと市が判断する者

## 支給条件

令和2年3月～令和2年9月のいずれかの月の売上が、前年同月と比較して**20%以上減少している**こと

※事業を開始した日から3か月以上1年1か月未満であっても、別に定める条件を満たす場合は支給を受けられます。条件について詳しくは、市ホームページをご覧ください。

※一度応援金の給付を受けた方は、再度の申請は出来ません。
